Cancellation policy

Cancellation before **22 April 2024**, Fros will refund <u>all</u> payments (more than 4 months before Championships).

Cancellation between **22 April 2024** and **24 June 2024**, Fros will refund <u>90%</u> of the deposited prepayment. (between 4 months and 2 months before the Championships).

Cancellation between **25 June 2024** and **22 July 2024**, <u>50%</u> of the whole to be paid amount will be refunded by Fros (between 2 months and 1 month before the Championships).

Last minute cancellation between 23 July 2024 and the start of the Championships, 20% of the whole to be paid amount will be refunded by Fros.

Championships cancellation:

We must inform that Fros will reserve the right of cancellation if there are not at least 4 member unions preliminary registered at **22 April 2024** (4 months before the Championships). In that case Fros will refund <u>all</u> payments.

Based on the provisional registration of athletes it will be decided if the Swimming championships will be cancelled. This decision will be taken directly after the **22 April 2024** (preliminary registration deadline) at the latest.

- 1. We advise you not to book any flight tickets before this date (22th of April 2024) and wait for a confirmation message from the host!
- 2. We advise you to proper insure your participants according to CSIT Sports Regulations! Fros accepts no liability as a result of uninsured participants!
- 3. We ask your attention for respecting the deadlines in this invitation. Not respecting the deadlines will result in exclusion of your participation.
